Objectives of the Competition:

- The competition is addressed to a wide range of talented youth and children, aesthetically sensitive and creatively active.
- A separate category consists of young artists from high schools of art.
- To inspire young artists to improve their artistic skills.

Rules of participation:

- Each institution can submit to the competition a maximum of 20 works in the format - A4 (210 mm x 297 mm), A3 (297 mm x 420 mm). Diptych, triptych will be treated as one work.
- Technique - drawing, painting, collage, printmaking, computer graphics, batik.
- an application card permanently fixed on the back of the work.
- please do not roll, frame or bend the submitted works.

Participants:

In the children's category:

Students ages:

"A" 6 - 9 years old,

"B" 10 - 13 years old.

In the youth category:

students aged:

"C" 14 - 16 years old,

"D" 17 - 20 years old.

Separate categories for art schools

students aged:

"E" 13 - 16 years old,

"F" 17 - 20 years old.

Evaluation of works:

The jury will evaluate the submitted works, awarding the Grand Prix and prizes and distinctions in each age category.

Awarded participants will receive prizes in kind funded by the organizers and sponsors.

Participants of the post-competition exhibition will receive diplomas and publications with published works.

Deadlines:

- Submissions with entry sheets will be accepted until 11.03.2024. (the date of the postmark is decisive).
- Announcement of the competition results on the website www.lspdabrowa.pl will take place by 11.04.2024.
- The official summary of the Competition combined with opening of the exhibition and presentation of prizes and distinctions will be held in the School Complex Gallery "Na Strychu" in Dąbrowa Górnicza on 31.05.2024.
- Prizes not collected during the vernissage can be collected from the school in person or will be sent back at the expense of the recipient.

General provisions:

- The organizer of the competition in the category for art schools is the Center for Artistic Education.
- The organizer of the competition in the children and youth category is the High School of Fine Arts in Dąbrowa Górnicza.
- The organizers reserve the right to make documentation in the form of bulletins, catalogs and to publish the submitted works on TV, Internet, press and other media without paying the authors' fees.
- Participation in the contest is tantamount to accepting the rules and agreeing to the processing of personal data by the organizers to the extent necessary to conduct the competition and further use of works.
- The works will be returned at the expense of the participant, the school or organization from which they were submitted.
- Participation in the competition is tantamount to transferring copyrights of the submitted works to the organizers of the competition.
- The organizers reserve the right to change these regulations.
- Participation in the competition is free of charge.

Personal data collected in the application form will be processed for the purpose necessary for organization of the competition and promotional purposes of the competition and its participants. Personal data will be stored for the period of time necessary to realize the specific purposes for which they were collected, as well as for the the period of asserting rights or claims. The recipients of the data of the personal data contained in the application form are:

- persons authorized by the Administrator to process the data in the performance of their duties related to the organization of the competition,
- entities to whom the Administrator subcontracts the performance of activities that involve the necessity of data processing (entities processing).

The contest participant (parent, legal guardian) has the right to access the content of his/her data and the right to their rectification, deletion, restriction of processing and the right to data portability, objection and withdrawal of consent to their processing at any time without affecting on legality of the processing that was carried out on the basis of consent given before its withdrawal.

Any data subject has the right to lodge a complaint with the Supervisory Authority, i.e. the President of the Data Protection Authority when he/she considers that the processing of personal data violates the provisions of Regulation 2016/679 of the European Parliament and of the Council on the Protection of Personal Data of April 27, 2016. (RODO). Provision of personal data is voluntary, but necessary for the purposes of participation in the competition. Failure to provide personal data will result in rejection of the application for participation in the competition.
